EXTRACT OF THE GOVERNING BODY RESOLUTION ADOPTED ON 22.09.2017

In view of the resolutions adopted in the Governing Body Meeting held on 20.06.2016 and the time frame sought by Sj. Harish Ganatra, Chairperson, Jharsuguda Municipality and Sj. Manoranjan Mahapatra, MP Nominee to settle the Land & Building issue of the college through Book Transfer by impressing upon the Government to waive the financial dues by the Cabinet within six months; nothing concrete could be achieved. Further, the members of staff in the meeting held on 04.03.2017 after appraisal by the Principal expressing his concern over the queries made by the Govt. authorities, unanimously resolved to request Hon'ble President G.B. to take immediate steps to settle the issue of alienation of land and building in favour of the college in accordance with the Govt. Letter No. 15260, Dt. 10.06.2016 through a suitable means of payment of the dues claimed.

As such, in view of the letter No. 1659, Dt. 20.09.2017 from the office of the RDC, ND, Sambalpur, an emergent meeting of the Governing Body was convened on 22.09.2017 at 10.00 AM in the Conference Hall of the Block Office, Jharsuguda and it was unanimously resolved that the President, Governing Body shall impress upon the District Administration to allocate development funds from different sources to the college for its developmental programmes and the college will remit the arrear dues from its own development fund..
