

**PROCEEDING OF THE GOVERNING BODY MEETING OF LAXMINARAYAN  
COLLEGE, JHARSUGUDA HELD ON 30.06.2019**

A meeting of the Governing Body of Laxminarayan College, Jharsuguda was held on 30.06.2019 at 3.00 PM in the IQAC room. The meeting was presided over by Sri Pratap Chandra Behera, MLA Representative in the Governing Body in absence of the President. The following discussions were held & resolutions adopted.

**Item No. 1 – Celebration of Golden Jubilee**

The Principal-cum-Secretary, Governing Body apprised the house about the ensuing Golden Jubilee year of the college. The college was established in 1969 and 2019 is the 50<sup>th</sup> year and held, if the house approves, there should be a grand Celebration of the Golden Jubilee.

It was decided to inaugurate the celebration on 18<sup>th</sup> of August 2019 presence of some VIPs and the final celebration November, December 2019 preferably in the 2<sup>nd</sup> week of December. It was decided to held the function with action participation of the Students' Union & Alumni Association. The Principal was authorized to form an organizing committee comparing a maximum of 30 members for the purpose. The Principal-cum-Secretary, Governing Body agreed to spend Rs. 1,00,000/- (Rupees One lakh) only for the purpose and it was decided to collect the rest amount from other sources.

**RESOLVED**

That, Rupees one lakh only be spent by the college authority for the Golden Jubilee celebration.

**Item No. 2 – Transfer of Land and Building**

Principal-cum-Secretary, Governing Body informed the house about the possible development regarding transfer of the existing Land with Building and waiver of the rental charges claimed by the Skill Development & Technical Education Department. The house authorized the Principal to hold discussion with Hon'ble Minister, Health & Family Welfare and President, Governing Body are to expedite the process.

**RESOLVED**

That, the Principal-cum-Secretary is authorized to hold talks and expedite the process.

Item No. 3 – Increase of Development fee & Hostel fee

The Principal-cum-Secretary apprised the house about the rising cost of electricity tariff, need of extra fund to hold union are other association functions & increase of salary payment due to large numbers of management staff and expressed his inability to manage the college smoothly without an increase in income. Similarly, the Hostel Superintendent of Girls' Hostel also prayed for an increase in hostel fee. The house deliberated on the issue & allowed an increase of Rs. 500/- in development fee and Rs. 150/- in hostel fee.

RESOLVED

That, the Development fee be increased by an amount of Rs. 500/- (Rupees five hundred) only and the hostel fee be increased by an amount of Rs. 150/- per student from the session 2019-20.

Item No. 4 – Appointment of Contractual Lecturers

The Principal-cum-Secretary informed the house a large number of teaching positions are lying vacant due to transfer, superannuation and death of members of staff. Since the peak academic session was about to approach the Principal prayed to be allowed to engage resource persons (Contractual lecturers) in the vacant post. The house thoroughly discussed the issue and decided to allow the Principal to engage contractual lecturers for the session 2019-20.

RESOLVED

That, the Principal be allowed engage contractual lectures with a remuneration of Rs. 8000/- per month in the following subjects.

3. Commerce – 02
4. Education – 01
5. Hindi – 03
6. Mathematics – 02
7. Odia -01
8. Political Science – 02
